Annual Dues

Annual Partnership Dues are based on your company's annual sales. How it works:

SMALL BUSINESS PARTNER

- For companies with annual sales less than \$250,000, annual dues are \$150.
- For companies with annual sales less than \$500,000, annual dues are \$250.

CORPORATE PARTNER

- For companies with annual sales greater than \$500,000, dues are \$1,000, per \$1 million in annual sales. This is capped at \$12,000 in annual dues to Leave No Trace. If your company's annual sales are less than \$1 million, annually, your partnership dues to Leave No Trace are \$500. Partnership dues are confidential.

Annual Dues

Annual Partnership Dues are based on your company's annual revenue. How it works:

- For companies with annual revenue less than \$500,000, Small Business Partner annual dues are \$250.
- For companies with annual revenue greater than \$500,000, Corporate Partner dues are \$1,000, per \$1 million in annual revenue. This is capped at \$12,000 in annual dues to Leave No Trace. If your company's annual revenue is less than \$1 million, annually, your partnership dues to Leave No Trace are \$500. Partnership dues are confidential.
